Assumption of the Risk and Liability Waiver

Please read carefully before signing — All participants are required to sign this form.

I have requested participation in a Great Old Broads for Wilderness (“Broads”) event. Broads furnishes services such as event planning and organization of outdoor recreational activities that will likely be lead on a volunteer basis. These outdoor recreational activities include, but are not limited to, hiking, camping, field works and car trips and transportation to and from such activities.

I understand and acknowledge that:

- (a) outdoor recreational activities have inherent risks, dangers and hazards and such hazards existing by virtue of my participation in such outdoor recreational activities and the transit to and from various venues where such activities may take place. Outdoor recreation activities have hazards which may result from activities with strenuous outdoor activities, including, but not limited to, injury or death from personal limitations, falling, hypothermia, drowning, rock falls, snake or insect bites, lightning strikes, equipment failure, weather conditions, or errors of trip leaders, volunteers or other participants or third parties;
- (b) my participation in such activities may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability;
- (c) outdoor recreational activities have risks and dangers which may be caused by the negligence of trip leaders, participants, officers, directors, executive committee members, or other members of Broads; the negligence of others outside of Broads; accidents; the forces of nature or other causes; and
- (d) by my participation in these activities, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the members, agents, officers, trip leaders or directors of Broads, or by any other person.

I, on behalf of myself, my personal representative and my heirs, hereby voluntarily agree to forever release, waive, discharge, hold harmless, defend and indemnify Broads and its members, officers and directors from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of service or other claim which may arise out of my participation in the various outdoor recreational activities that may be sponsored, directed, organized or otherwise sanctioned by Broads. I also accept and assume the inherent risks of participating in these outdoor activities.

I hereby consent that any photograph in which I appear may be used without compensation to me for the purposes of publicity or advertising, such as catalogues, flyers, and news stories.

I acknowledge that I have the physical conditioning and stamina for the activity that I am participating in. I assume all responsibility for determining whether or not a particular activity or trip is appropriate for my current level of fitness and conditioning. I understand that my participation in an activity that is beyond my physical limitations may cause harm and inconvenience to myself and others.

This agreement is governed by and shall be construed in accordance with the laws of the State of Colorado, without any reference to its choice of law rules. I agree that any dispute arising from this Agreement or in any way associated with the Event shall be brought only in the State of Colorado, and I agree to the jurisdiction and venue of the District Court of La Plata County, Colorado or in the US District Court for the District of Colorado, in Durango, Colorado, for any such dispute.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND AGREE IT IS MY INTENTION TO EXEMPT AND RELEASE Great Old Broads for Wilderness FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE. I AM AT LEAST EIGHTEEN YEARS OF AGE AND UNDER NO LEGAL DISABILITY.
