Late Friday we learned that the Utah Court of Appeals granted our motion for a stay of the proceedings in the trial court pending their consideration of our petitions for interlocutory appeal (appeal prior to trial). Woo hoo! No trial this week. Thinking positive thoughts that they will accept our appeal.

Helpless and hopeful – two strong emotions jockeying for position in my mind and heart each hour of each day. We know we are innocent of any criminal wrongdoing. Yet we are pawns in an ugly legal game that has potentially serious consequences. Beyond hiring the best legal team we could find (and paying said team well) there is little we can do individually to speed the process or affect the ultimate resolution. Helpless. Not something either of us are accustomed to!

Hopefulness is what keeps us strong. We must believe that justice will prevail; the system will work as it should for innocent people. We know our attorneys are extremely talented and capable and are doing everything they can to ensure we receive justice. They have succeeded in having our trial moved to Carbon County, UT where fewer people have been poisoned by the hate and lies about us prevalent in San Juan County. We are buoyed by the words of concern and support from so many people – colleagues and friends, family and total strangers. The financial support many have provided humbles us and strengthens our resolve to stand strong and hopeful that we will prevail.

The legal machine is grinding along; sometimes fast and sometimes excruciatingly slow. Motions have been filed (for allowing Mark's polygraph test to be considered, for the County Attorney to recuse himself, for the offered plea agreement dismissing all charges against Rose to be enforced, for a change of venue out of San Juan County). Judge Anderson has denied all but the change of venue.

Now we are requesting the Utah Court of Appeals look at our case in the interest of justice. There is no evidence against Rose to support the charges against her. There is no evidence of criminal intent regarding Mark's closure of a gate in a fence that had a large gap in it. It is Rose's association with a conservation organization that is driving this malicious prosecution and we believe this to be a serious violation of our constitutional rights to free speech and association. Fourteen conservation organizations have joined together and filed an Amicus (friend of the court) brief. We wait for the Appeals Court to decide if they will review our case.

In the meantime, the Prosecuting Attorney amended his criminal complaint on May 1st – the felony charge "Retaliation Against a Victim, Witness or Informant" against Rose has been dropped! This is good news!! Mark and I are facing the same two charges – Felony Attempted Wanton Destruction of Livestock and Misdemeanor Trespassing on State Trust Lands with an Animal Operation. Interesting how these unfounded charges against Rose are oneby-one being dismissed. We continue to hold out hope that justice will prevail and all these criminal charges will be dropped! No crime was ever committed by either of us!!

Another week gone by and we wait for answers to the various Motions our attorneys have filed regarding our case (Motion to Quash, Motion to Enforce Plea Agreement to Dismiss all Charges Against Ms. Chilcoat, <u>Motion to</u> <u>Disqualify the San Juan County Attorney's Office</u>). The waiting is hard. It is like suspended time...wondering what the future of our case might bring. The Huffington Post just ran an article about our absurd criminal case - <u>Her</u> <u>Husband Closed a Gate on State Land, Now Utah Wants to Put Her in Jail For</u> <u>21 Years</u>.

In a breathtaking turn of events, last Wednesday San Juan County Prosecutor Kendall Laws offered a plea deal to dismiss all charges against Rose! At the same time, he offered Mark a deal to plead guilty to two misdemeanor charges – trespass (unchanged) and Attempted Wanton Destruction of Livestock (down from a class 2 felony). I accepted the Dismissal offer but Mark did not take the plea deal. Subsequently, Laws attempted to backpedal the deal. It was a full year ago that our mailman came to the door serving us with a "Summons" to appear in the 7th Judicial District Court in Monticello, San Juan County, UT regarding criminal charges. We've since experienced a full year of life suffering financial, emotional, mental, and physical upheaval; our time and peace of mind lost forever. We await a trial date which is currently set for May 23-24.

NEWS FLASH! Last Monday, legal scholar <u>Paul Cassell</u> entered as co-counsel for the defense. We are so excited to have him on our team. As he said, "I don't usually do criminal defense work and haven't worked with

environmentalists before, but because this case raises such disturbing First Amendment and other concerns, I felt it was important for me to get involved."

Since then our legal team filed a <u>MOTION TO QUASH</u> with the Monticello District Court. This document spells out the reasons why we should not have been bound over for trial on the charges. Last Friday afternoon Kendall Laws, the Prosecuting Attorney, responded to the court regarding our motion. Our attorneys today filed a <u>REPLY IN SUPPORT OF MOTION TO QUASH BINDOVER</u>, again pointing out the <u>politically motivated and retaliatory nature</u> of these unfounded charges and we now await Judge Anderson's ruling.

It's been a long time since our last update. Welcome to our world...the world of waiting. And waiting some more. And just when you think things are ready to move forward you get to...wait some more. For folks like us who are used to getting things done the waiting that is involved as a defendant in the criminal justice system is one of the hardest parts. I suppose I can call this enforced learned patience.

Here's the latest news:

* Our cases, at the County Attorney's request, have been joined. This means one trial date and one trial that covers the both of us. This is not particularly good or bad.

* Our trial date of January 31 has been cancelled and the case is continued with no new date set at this time. (Deep sigh here.)

* The court prohibited, pending a hearing, our defense team from conducting independent professional polling in San Juan County, UT that was to be part of our Motion for a Change of Venue to a different county.

Meanwhile, the legal expenses continue to mount and now significantly exceed our initial fundraising target. We have the utmost confidence in our legal team but great representation doesn't come cheap. With a new year underway we again thank those who have already been so generous and ask for your help sharing our plight with others who may be able to help.

We had our preliminary hearing Thursday in Monticello, UT. Finally, after nearly 7 months wait, we learned exactly what "crimes" the prosecution believes Mark and I committed and what evidence they have to support those allegations. One misdemeanor charge against Rose (providing false personal information to a police officer) was dismissed by the Judge. I guess after 30 years of marriage this month it is OK to agree with the officer that she goes by Franklin as well as Chilcoat!

In spite of an overwhelming lack of evidence, we were bound over for trial on the other charges (2 felonies, 1 misdemeanor for Rose and 1 felony, 1 misdemeanor for Mark). We also had the opportunity to respond to the court on each of the charges as "NOT GUILTY". Trial dates were set for January 31 and February 1, 2018. The injustice of unfounded, politically motivated and retaliatory criminal charges against us will continue to unfold.

Thanks to all who kept us in their thoughts and hearts Thursday. Thanks also to all who have been able to help defray our substantial legal expenses. Your support means so much to us.
