

In 2024, Great Old Broads for Wilderness continued training women as stewards and advocates for our country's wilderness and wildlands. Over the last fifteen years, Broads has developed successful methods to recruit, organize and support advocates for public lands, water and wildlife. Our Grassroots Leadership Program builds education, fun, and camaraderie into every activity to keep grassroots members inspired and connected. With 40 grassroots chapters in 18 states and individual members across the nation, we launched or participated in stewardship, restoration and monitoring projects to enhance ecological health and wildlife habitat in wetlands, rivers, forests, deserts, and more. Chapters reported 3,693 volunteers contributing over 31,000 volunteer hours and more than 5,600 of those hours were related to monitoring and stewardship activities.

Broads hosted eight educational webinars with hundreds of participants on topics like the Old Growth Forest Amendment, Voluntary Grazing Retirement Act, Greater Sage-Grouse Management Plan, Bears Ears Cooperative Management Plan, and hosted webinars for Broadband Leaders. We served on coalitions to support public lands and conservation, and participated actively in agency committees and gathered data in the field to document conditions and provide information related to agency plans.

We brought a strong voice for public lands from rural communities. Many of our grassroots groups are based in small communities like Cortez, Ridgway, Grand Junction, Middle Park and Northwest Colorado; Silver City, NM; Prescott-Yavapai and northern Arizona; southwest Utah; northwest Montana; western Wyoming; and eastern Idaho. We demonstrated that rural communities care about protecting wildlife and wildlife habitat, promoting quiet recreation, ensuring clean and plentiful water, and promoting clean air. We represented rural, small town, and urban communities that want to ensure public lands remain in public hands, the Wilderness Act stays intact, and land management agencies have the staffing, funding, and public backing they need to do their jobs.
