- Permit Updates:
 - Local:
 - NB Public Hearing- Tuesday, November 24
 - <https://rogueclimate.org/north-bend-city-council-public-comment-guide/>
 - Land use permit expired in October 2020 and company is requesting an extension.
 - LUBA: still have not heard back from LUBA about 3 appeals and there are more briefings being worked on by Crag and Tonia
 - All 4 entities signed off on the Enterprise zone
 - \$12 million split between NB, CB, CC, Port of Coos Bay so Jordan Cove can not pay taxes while they build
 - Question?
 - Do they only start paying once they start building?
 - Natalie -- Still things going on w/ charging fees to CFR for the appeal in North Bend
 - Natalie will call Tonia in the AM
 - State:
 - No reapplications or talk there of
 - Federal:
 - Chaterjee demoted from chair as FERC -- same makeup but now Danly is chair
 - Demoted cause he likes carbon pricing

- Cow creek tribe sent in a letter to FERC that FERC failed to do government to government consultations

- Election Brainstorm -- Allie
 - What local shifts have we seen?
 - South Coast
 - Coastal Caucus Arnie & Caddy shift to republicans Dick Anderson & Boomer wright
 - Green Party Candidate (opposed to JCEP) got 4% of the vote, which is what Melissa Cribbins (supporting JCEP) lost by
 - Dick Anderson likely supports Jordan Cove LNG but didnt put it on his website
 - Cal M (supported JCEP) the Democrat also lost to a Republican who didnt put JCEP on their website
 - DeFazio won again, now opposed to Jordan Cove -- closest congressional district in the state only won by 5%
 - Still chair of transportation
 - Fewer democrats in the caucus that support Jordan Cove LNG
 - Substantial story to tell -- that supporting JCEP is why the Dems lost the South Coast
 - Rosenblum kept her seat and DOJ is doing good stuff on JCEP
 - Shemia Fagan -- now on State Lands Board, first dem to have it in awhile
 - Unknown how she will be on JCEP b/c of connection w/ Building Trades, but was super progressive in the Senate
 - Her official position on "Oil + LNG" is that they should be regulated -- very Building Trades
 - Was primaried pushed by No LNG Champ, Jamie
 - Could be a likely candidate for Gov after Brown
 - Media asked her about this and pledged to fill out her full term
 - Audit power of Secretary of State
 - JCEP has not paid for all of the time that DSL put into their application
 - PDX -- Green New Deal Champs -- Khanh Pham, Ricky Ruiz, etc <3
 - Some doctors added in too that OPSR is building relationships with
 - Joe Biden
 - What does he agree with us on?
 - Publicly committed to ending subsidies for fossil fuels
 - Supports the Clean Water Act and could restore the integrity of regulations
 - Kamala has supported GND and Medicare for All for like 24 hours
 - Climate change is an issue and he campaigned hard on it

- Owes a lot to progressive climate orgs who organized for him
 - He committed to integrating climate change considerations into all agencies
 - Campaigned hard on Indigenous sovereignty
 - Eminent domain issue is probably not his favorite either
 - What does he not agree with us on?
 - Joe Biden likes fracking
 - Kamala at debate “We will not ban fracking”
 - Campaigned hard in PA + TX, but lost the fracking counties to Trump
 - Export LNG \$\$ and trade \$\$
 - Jobs in fossil fuels -- economic crisis
 - What are ways we can influence the President-Elect?
 - Pressuring Federal Delegation
 - Merkley, Wyden, DeFazio
 - Record against
 - Blumenauer and Bonamici
 - PDX needs to get these folks opposing JCEP
 - Sign on letter from OR Fed Delegation to administration
 - Tribal Nations
 - Gov B
 - Sign on letter to oppose Ernest Moiz as Energy Secretary
