Summertime Wilderness Monitoring 2023

Are you starting to dream of summer adventures in the Cascades? Maya Abels and Lynn Humphrey are in active talks with OSU and the Forest Service about writing another grant to conduct wilderness monitoring in **July and August**. Volunteers will be reimbursed for mileage, will receive a t-shirt and hopefully some other perks. You would be expected to participate in training and then spend time walking the trails. Our preference will be for volunteers to backpack in and camp at least one night on the trail. For those of you who get motivated, you can earn a Central Cascades permit for 2024 that will allow you to hike wherever and whenever you want to go. You won't have to apply for a permit because you'll receive a permit that allows you to take one other person with you.
